



2023 Ridges Sanctuary Hunting/Trapping Registration Form

Portions of The Ridges Sanctuary are open to hunting and trapping. Maps of The Ridges lands open to hunting and trapping are available from the office, as well as on our website, www.RidgesSanctuary.org. Wisconsin Department of Natural Resources rules and regulations and Ridges Sanctuary Special Hunter Provisions must be obeyed.

Hunters are **required** to read and fill out the 2023 Registration Form below and mail or email the bottom portion to The Ridges Sanctuary before hunting on The Ridges' lands. Hunting without prior registration, or violation of any stated rules, will be cause for automatic denial of permission to hunt on The Ridges' property in the future.

Hunting Regulations

- **Do not hunt within 50 feet of any established trail or building in The Ridges Sanctuary.** Hunters are responsible at all times for understanding where they are on Ridges' property and the associated rules for that area.
- **No** motorized vehicles, including ATVs, are allowed outside designated parking areas.
- Bringing in any bait or salt blocks is **not permitted**. The use of tree stands, even temporary, is **prohibited** on Ridges' properties. Temporary ground blinds are permitted but are not allowed to remain up overnight. All overnight or unauthorized stands/blinds will be confiscated.
- The cutting, destruction, or removal of live or dead trees, anything living or non-living, except for lawfully taken animals, is **forbidden**.
- The Ridges Sanctuary Board of Directors, its members, and staff **will not accept responsibility or be liable** for accidents or incidents resulting in injuries, loss of life or damage to personal property to any and all hunters/non-hunters that may result from a hunting situation. By hunting on lands owned by The Ridges Sanctuary **you agree to abide by the rules and regulations of the State of Wisconsin, the Department of Natural Resources, and Ridges Sanctuary Special Hunters' Provisions.** All those found in violation will be prosecuted to the fullest extent of the law. Report all unlawful acts to The Ridges Sanctuary, DNR personnel, and/or local law enforcement officers.
- **Please notify The Ridges Sanctuary about your hunt, especially deer kills.** The response of hunters and the information received will be used to determine future hunting and trapping seasons. E-mail Land Manager Sam Hoffman, send a letter to the address listed below, or call The Ridges' office at 920-839-2802. Include the following information: location of hunt, days hunted, number in party, deer seen, deer killed, information that would be helpful to manage deer, and any problems you may have encountered during your hunt.
